Where We Started

- Effective July 1, 2023, ASGARN and State Coordinator position were moved from GOCI to MDOD.
- Hired new State Coordinator for Autism Strategy.
- Reviewed the statute at length and have consulted our AAG so we **move forward in a way that** ensures compliance, process, and transparency.
- Coordinated with GOCI to compile as much documentation as possible from previous coordinator.



What We Found

- Under ASGARN's previous home and leadership, **compliance**, **process**, **and transparency were severely lacking**.
- Documentation was poorly organized and unsubstantial.
- Multiple membership lists existed and had conflicting or incomplete information.
- Appointing authority of the previous coordinator was practiced without process or transparency.



Why Findings are Problematic

- Out of compliance with statute.
- Poor foundation for new coordinator to build on.
- Large list of individuals associated with ASGARN, but no way of determining full voting members vs. interested parties.
- Lack of policy, process, and procedure has made forward progress challenging and will continue making forward progress challenging if the status quo is maintained.



Where We Need To Go

- Ensure the charge of ASGARN is implemented with fidelity, and that **compliance**, **process**, and **transparency guide our forward progress**.
- Comply with all deadlines and reporting requirements.
- Establish policies that promote process and transparency.
- Address the problematic findings discussed previously.



How We Get There

- Implement new policies and procedures that promote compliance, process, and transparency.
- Comply with all deadlines and reporting requirements established in statute.
 - o Complete strategic plan by July 1, 2024.
- Maintain and display publicly detailed notes and minutes of ASGARN meetings on MDOD website.
- Maintain an updated and clear membership list that is displayed publicly on MDOD website.
- Utilize Robert's Rules of Order to facilitate ASGARN meetings.



Reorganize and Recalibrate.



How We Get There

Reorganize and Recalibrate

- Work adopted under previous coordinator will go back to the respective subcommittees for further discussion and collaboration.
- Membership will be brought back to statutory baseline.
 - Statutory Baseline = Governor Appointed, Ex-Officio, MGA Appointed
- Due to poor documentation, individuals appointed by the previous coordinator will be removed as full-voting members.
 - Can still engage with group by attending meetings, through public comment, or by being re-appointed by coordinator.
 - Membership committee will be formed to review applications and advise the coordinator on additional appointments.

- Within the next 60 days, we will be forming a membership committee for applications for memberships to ASGARN appointed by my position, and start reviewing applications. We hope to make the call for applications as widely known as possible across the entire autism community in the state I want to prioritize ensuring a diversity of views and lived experience.
- As we move through the goal of having the strategic plan ready for submission on July 1st, 2024, ASGARN will play a crucial role as an advisory body of stakeholders to provide suggestions and feedback for the process, and give it transparency.



The next quarterly meetings of ASGARN for the fiscal year will be at 1 PM December 12th, 2023 March 12th, 2024 and May 21st, 2024.
